3. All advance written notice of said meetings throughout the time period covered by this Resolution shall be mailed to all persons requesting a copy of the same after payment by such persons of a fee of Twenty-five dollars and no cents

(\$25.00), payable to the Board of Fire Commissioners, Fire District No. 2, Bordentown Township. News media shall not be exempt from such fee.

4. All advance written notice of meetings shall be provided, by the Commission Secretary, to the Clerk of Bordentown Township.

5. The schedule of Commission meetings from, and after, this reorganization meeting until the next reorganization meeting on March 1st, 2022, shall be accordance with the schedule annexed here to designating the dates, times and places of such meetings.
