- ____ Matters relating to public safety and property.
- ____ Matters relating to litigation, negotiations and the attorney-client privileges.
- \underline{X} Matters relating to the employment relationship.
- ____ Matters relating to the potential imposition of a penalty.
- _____ Matters relating to the deliberation of administrative and/or quasi-judicial matters.
