- Checks, drafts, notes or acceptances drawn on PNC Bank account 1. number 80-4120-3812 (checking account for operational expenses) shall require three (3) signatures, and;
- Checks, drafts, notes or acceptances drawn on PNC Bank account 2. number 80-4120-3839 (payroll account) shall require one (1) signature or be payable as an electronic fund transfer.
