RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT. N.J.S.A. 10:4-12

Matters involving individual privacy.

Matters relating to the purchase, lease or acquisition of real property of the
investment of public funds.
Matters relating to public safety and property.
_X Matters relating to litigation, negotiations and the attorney-client privileges.
Matters relating to the employment relationship.
Matters relating to the potential imposition of a penalty.
Matters relating to the deliberation of administrative and/or quasi-judicial matters.
