ADOPTION OF MINUTES:

The minutes for Regular Meeting held on July 11, 2024 were presented for approval. Chair, Cann requested a motion to approve the aforementioned minutes. A motion was made to accept the July 11, 2024 Minutes. A motion was made by Andrew Law and Seconded by George Gareis. A ballot was taken and all members present approved the motion to accept the Regular Meeting Minutes for July 11, 2024.

REPORT BY CHIEF BTFD#2:

Report prepared by Chief, Robert MacFarland (BTFD #2) for July 2024 was presented by Capt. Scully who provided highlights. Chair Cann requested if the BTFD#2 Commissioners had any questions. A motion to approve the Chief's Report for July 2024. A motion was made by George Gareis and Seconded by Andrew Law to approve the report. A ballot was taken and all members present approved the motion to accept the July 2024 Report.

Highlights:

- Capt. reported regional grant for BTFD#1 and 2 and Chesterfield FD \$462,909
- FF List was received from NJ Civil Service.
- Capt. reported that the PO for Fire Truck purchase approved pending final action by State.

- Capt. reported that water restrictions for the municipalities serviced by Bordentown City were in place.
- Capt. Reported that the architectural services for construction projects including the roof total \$14,650.
- AC down in the Bunk Rooms, Office and Collation Room. Repairs will be made on an emergency basis and reported back to the BTFD#2 Commissioners upon completion.

REPORT BY TREASURER:

Treasurer Robert Bennett presented the July 2024 Finance Report. The July Finance Report listed 15 bills totaling \$37,118.43. Chair, Cann requested a motion to accept the Treasurers July 2024 Report. A motion was made to accept the report by Andrew Law and Seconded by George Gareis. A ballot was taken and all members present approved the motion to accept the July 2024 Report.

OLD BUSINESS:

Capt. Scully requested approval of the Fire Truck PO to be issued August 14, 2024 pending final approval by the State Local Finance Board. A motion was made by Andrew Law and Seconded by George Gareis. There was no further discussion and the motion was affirmed by all Commissioners present.

Capt. Scully presented a proposal from the BTFD#2 Accountant to prepare State and Local Budget forms for review by the BTFD#2 Fire Commissioners and submission to the State upon final authorization by the BTFD#2 Fire Commissioners. The fee was established a \$1,800.00 with a price not to exceed \$2,000. A motion was made by Andrew Law and Seconded by George Gareis. There was no further discussion and the motion was affirmed by all Commissioners present.

Capt. Scully presented a proposal from KLK Refrigeration, LLC to perform emergency repairs to the Air Conditioning discussed in the Chief's Report. The estimated cost for the Air Conditioning repairsfee was **estimated to be \$6.675.00**. A motion was made by Andrew Law and Seconded by George Gareis to make the emergency repairs at a **cost not to exceed \$6,675.00**. There was no further discussion and the motion was affirmed by all Commissioners present.

Capt. requested approval for the following expenses:

Motion made by George Chidley to approve the expenditures and Seconded by George Gareis All members present approved the motion.

MOTION TO GO INTO CLOSED SESSION:

At 7:32 pm Chair Cann requested a motion to go into closed session to discuss personnel and contract matters pursuant to Resolution 2024-0029. A motion was made to go into closed session by George Gareis and Seconded by George Chidley. A ballot was taken and all members present approved the motion. The Chair announced that after the Closed session the meeting would be reopened for public comment before adjourning.

MOTION TO REOPEN TO THE MEETING:

At 7:49 pm return from Closed Session. Chair Cann requested a motion to approve the Burlington County Professional Firefighters Association IAFF Local 3091 Contract 2024-2026 for approval and signature by the IAFF Union and final execution by the Chair, BTFD#2 Board of Fire Commissioners. A motion to approved the FF Contract was made by Andrew Law and Seconded by George Chidley. Chair asked if there was further discussion on the pending motion. There was no further discussion and a roll call ballot was taken:

There were no additional members of the public present seeking to be heard. Chair Cann requested a motion to close the meeting for public comment. A motion was made by George Chidley to close the meeting for Public Comment and seconded by Andrew Law. All members present affirmed the motion to close the public comment portion of the meeting.
