Station:

An inspection of the roof was made by the Architect his assistant, and two perspective bidders on 12/4/24. In attendance was Commissioner Law and Capt. Scully

Of note both contactors stated that they would not leave any roofing demolition open without fully making final repairs by the end of each day. Any disruption of company Page 3

operations does not seem likely. Of note a 3-yard dumpster and parking for employees and equipment will be necessary during the 30 day (estimated) time for demo, and replacement of the roof system.

Treasurers Report:

Purchases by Vendor 12 1-4, 2024 totaled \$18,094.41 J. Cann called for a motion to pay vendors in that amount, moved by A. Law and seconded by G. Gareis carried by J. Cann, A Law, R. Bennett and G. Gareis.

\$100,000 transferred from fringe benefits to salaries and wages \$15,000 transferred from miscellaneous supplies to salaries and wages \$25,000 transferred from station maintenance to apparatus maintenance \$10,000 transferred from administrative salary to professional services \$5,000 transferred from commissioner salary to professional services \$5,000 transferred from hydrant rentals to dues and subscriptions \$2,500 transferred from health and wellness to elections \$2,500 transferred from training and education to equipment testing.

Chairmen Cann requested this motion #2024-0040 be made to approve the 2024 budget line-transfers. Moved by G. Gareis seconded by A. Law. The motion was approved by J. Cann, A. Law, G. Gareis and R. Bennett

Capt. Scully submitted the Chief's and his proposal to carry over unused vacation time into the 2025 fiscal year. J. Cann requested a motion to approve the carry overs in the 2025 year. This was moved by A. Law and Seconded. A discussion followed and it was amended to state the 2025 to be used by 12/31/25. The motion was approved as amended and passed by J. Cann, A. Law, G. Gareis and R. Bennett

Discussion on the Safer Grant:

Concerns were raised by J. Cann that though the grant covers the costs for the newly hired firefighters, at issue there is no assurance that the funding by the pubic will cover the continuation of those hired be maintained after the grant funding was closed. Without the ability to ensure that the positions be retained the Fire Company could be in a position to let those individuals go at the end of the Safer Grant period. It was agreed that at this time we are not recommending the processing of this grant.

The cap compliant budget previously submitted by the Chief's submittal was approved by motion requested by J. Cann by A. Law, Second by R. Bennett. All members present approved of the motion.

Comments by J. Cann, he indicated that we need to review the CNC 3. He is of the opinion that the Company would be placed in financial hardship and not be able to meet near future expenditures unless we revisit the 2025 budget and seek additional financial support from the District above the 2% limit on expenditures imposed by the State and the lack of funding through the Taxing district on the overwhelming warehouse structures constructed in District 2.
