#### **REPORT BY CHIEF BTFD#2:**

Report by Chief, Robert MacFarland (BTFD #2) for February 2024 dated March 4, 2024 was presented. Chief noted that Commissioner bennett completed the ½ hour training required for the Treasurer position.

The County of Burlington certified the results of the ballots for the two Questions: Question #1 Fire Engine Acquisition PASSED. Question #2 Salaries and Improvements also PASSED by a slim margin.

LT Asbrand is working on an American Rescue Plan Grant to obtain \$74,000 for PPE pursuant to RESOLUTION 2023-0019. This will be a joint grant with Chesterfield FD and Mission 1 FD.

There was a 500lb food drop to the Burlington County Animal Shelter. A letter of thanks was received.

HAAS Report for February included 1309 motorists alerted to our activity on 49 incidents with an average on-scene time of 26 minutes.

Residential Structures on Dunns Mill Road have been offered by the owner for fire training. There was a brief discussion related to the lack of local fire coverage in Mansfield Township. The Fire Commissioners present expressed concern that Mansfield was no-longer meeting it's obligations and BTFD#2 cannot continue to respond. The Chief was asked to contact the Municipality and report back at the next Regular Meeting.

Photos of Derby Fire Station donated by Tim Lang were reviewed by the Commissioners.

Chair, Cann requested a motion to accept the Chief's February 2024 Report. A motion was made to accept the report by George Chidley and Seconded by George Gareis. A ballot was taken and all members present approve the motion to accept the Chief's February 2023 Report.

#### REPORT BY TREASURER:

Treasurer, Robert Bennett presented his Finance Report for March with 27 bills totaling \$44,786.93.

Chair, Cann requested a motion to accept the Treasurers March 2024 Report. A motion was made to accept the report by George Chidley and Seconded by George Gareis. A ballot was taken and all members present approve the motion to accept the March 2024 Report.

#### **OLD BUSINESS:**

Chief MacFarland reviewed the Inter-agency Agreement for Oxygen Re-Charge Unit Agreement with the BTFD#2 Commissioners. A motion was made by Commissioner Andrew Law and seconded by George Chidley. A ballot was taken and all members present approved the agreement and delegated signature authority for the Chief to execute it on behalf of BTFD#2.

BTFD#2 Commissioners received the 2022 Audit. After a review of the Audit Findings a motion was made by Commissioner Andrew Law to accept the 2022 Audit Report in its totality and Seconded by George Gareis. A roll call vote was held and approved by the members present.

BTFD#2 Commissioners reviewed RESOLUTION 2024-0017. The resolution was prepared by Commissioner Andrew Law and the Solicitor. After review by the BTFD#2 Commissioners a motion was made by Commissioner Andrew Law to accept RESOLUTION 2024-0017 Authorizing Purchase of a Fire Truck and Seconded by George Gareis. A roll call vote was held and approved by the members present.

#### **NEW BUSINESS:**

Chief requested approval for the following expenses:

Motion made by George Chidley to approve the expenditures and Seconded by George Gareis. All members present approved the motion.
